Select	I met with [REDACTED] who came to see me with Peggy L. She spoke about a n incident in December where she was sexually assaulted. She informed me that * (who she dated for a short period of time) called her one evening in December at 1:00am. She stated that she told him she was drunk but, that she would come over. She said that when she got to his apartment the door was open and she then layed down on the couch. She did not see him when she came in but, he did then enter the room and make the statement to her that she looked really drunk and she again confirmed. She said that it was long before he sat down next to her and started to kiss her. She said she did kiss him back. She siad that things started to happen very fast and that he tried to take her pants off of her and she held onto them saying "no *". She siad he was able to take them off anyway. She said he then tried to perform oral sex on her but , she closed her legs and said "no" again. She said that he then held them open. She said that he made a statement about how she "tasted". over and was laying on top of her. She said that he tried to have sex with her from behind and that it hurt and she jumped up and away. At this time she said she started to cry and told him to stop. She said he then stuck his penis into her vagina while she said no and to stop. She said he did ejaculate in her and then climbed off of her. She said that she stayed there until he was asleep and then left.

She said that she went to take back the night and started to relive what happened. She decided that she did want something to happen to him. She did go to the hospital but, only later to get checked for disease. She also said that she saw him once and he seemed to react to her like nothing happened. She wanted a directive and it was sent on Friday, April 21.
